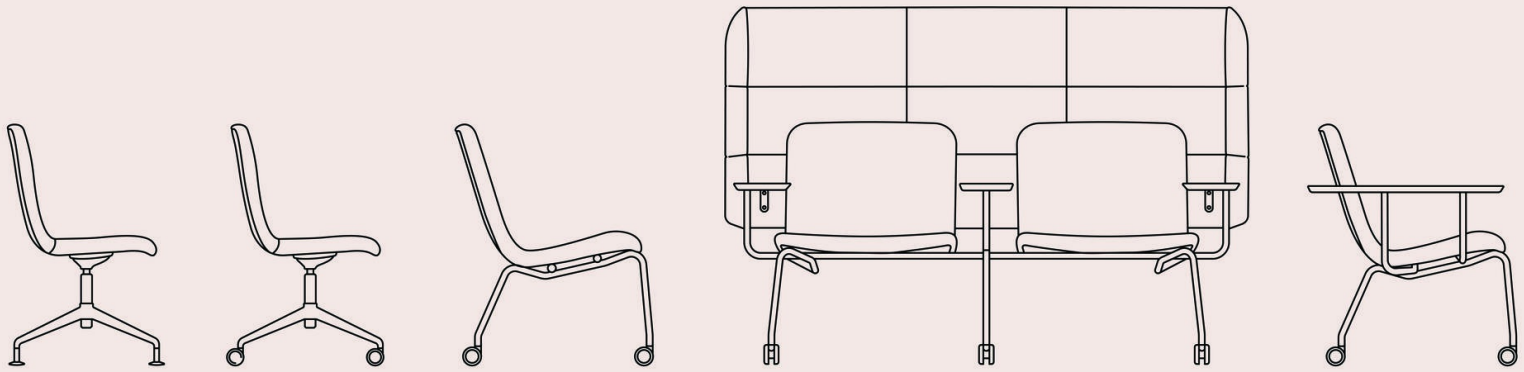

EFG Hybe is a flexible seating and meeting solution designed to support focused work, collaboration and short interactions in dynamic environments. The series includes upholstered units in various sizes, available with fixed legs or castors for mobility. Its soft shapes and modular elements make Hybe suitable for offices, schools and shared spaces where adaptable furniture is needed.

### Product specification

The model analyzed in detail in this declaration is the 1-seater with castors and polyester fabric including packaging.

### Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

### Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

### Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.

2. This impact category deals mainly with the eventual impact of low dose ionizing radiation on human health of the nuclear fuel cycle. Potential ionizing radiation from the soil, from radon and from some construction materials is also not measured by this indicator.
